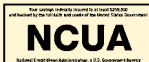

Notice To Members Eligible To Vote

The Annual Meeting of the Members of 1199 SEIU Federal Credit Union will be held in the Gallery meeting room at the main lobby, 310 West 43rd Street, New York, New York 10036, on Thursday, June 27, 2013 at 6:00 p.m., for the election of directors and for the transaction of such other business as may properly come before the meeting.

There will be filled at the meeting four director positions. The Board has nominated to fill these positions the following current members of the Board of Directors:

Dalton Mayfield. Mr. Mayfield currently serves as Chairman of the Credit Union's Board of Directors, and has served in such capacity for over thirteen years. Mr. Mayfield is employed as Vice President of 1199 SEIU, and has served in such capacity for over 13 years.

Aida Garcia. Ms. Garcia currently serves as Vice-Chair of the Credit Union, and has served in such capacity and as a member of its Board of Directors for approximately thirteen years. Ms. Garcia was employed Executive Vice President of 1199 SEIU, and served in such capacity for over ten years.

Patricia Smith. Ms. Smith currently serves as Treasurer of the Credit Union, and has been a member of its Board of Directors for over eight years. Ms. Smith is employed as Vice President of 1199 SEIU, and has served in such capacity for over eight years. Prior to her employment with 1199 SEIU, Ms. Smith was employed as Area Director of Local 144.

Isaac Nortey. Mr. Nortey currently serves as a member of the Board of Directors of the Credit Union, and has served in such capacity for over eight years. Mr. Nortey is employed as Vice President at 1199 SEIU, and has served in such capacity for over eight years. Prior to his employment with 1199 SEIU, Mr. Nortey was employed as Area Director at Local 144.

Pursuant to the Credit Union's By-Laws, nominations for the four director positions may also be made by a petition signed by at least 1% of the Credit Union's members, that is, signed by at least 295 members. Each signature should be accompanied by the member's printed name and address for purposes of verification. Each nominee by petition must submit to the Secretary of the Credit Union, together with his or her petition, a brief statement of qualifications and biographical data. All nominations by petition must be delivered to, and received by, the Secretary of the Credit Union by no later than May 15, 2013. In order to be effective, nominations by petition must be accompanied by a signed certificate from the nominee stating that he or she is agreeable to nomination and will serve if elected to office. At the annual meeting, if the total number of nominees equals the total of positions to be filled, that is, four, the election will not be conducted by ballot and there will be no nominations from the floor.
