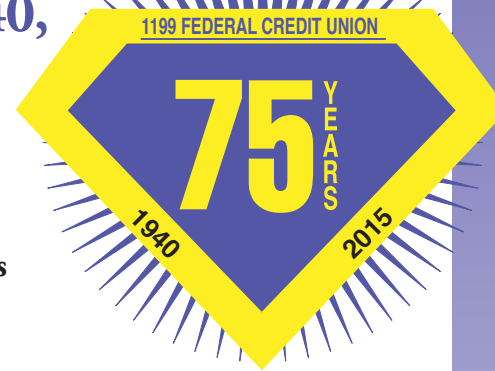

Notice to Members Eligible to Vote



The 75th Annual Meeting of the Members of 1199 SEIU Federal Credit Union will be held in the first floor meeting room, 310 West 43rd Street, New York, New York 10036, on Thursday, June 18, 2015 at 6:00 p.m., for the election of Directors and for the transaction of such other business as may properly come before the meeting.

There are two Director positions open that will be filled at the meeting. The Board has nominated the incumbent Board Members, Stephen Joseph and Roy Hendricks to fill these positions for the term of 3 years.

Pursuant to the Credit Union's By-Laws, nominations for the one Director vacancy may also be made by a petition signed by at least 1% of the Credit Union's members; that is signed by at least 289 members. Each signature should be accompanied by the member's printed name and address for purposes of verification. Each nominee by petition must submit to the Secretary of the Credit Union, together with his or her petition, a brief statement of qualifications and biographical data. All nominations by petition must be delivered to, and received by, the Secretary of the Credit Union no later than May 15, 2015. In order to be effective, nominations by petition must be accompanied by a signed certificate from the nominee stating that he or she is agreeable to nomination and will serve if elected to office.

At the annual meeting, if the total number of nominees equals the total positions to be filled, (two), then no election will be conducted. There will be no nominations accepted from the floor.
